The following provides additional information concerning the capabilities, specialized revegetation equipment, procedures, and other details specific to this Rawlins Landfill Phase II Closure Seeding Project.

Rocky Mountain Reclamation has provided revegetation and erosion control services to a number of landfills in the region including Wamsutter, Laramie, Wheatland, and Casper. Our work experience as is true for this project includes compost application and incorporation, slope mulch application and incorporation, seedbed preparation including scarifying and/or discing as necessary to properly prepare the seedbed, drill seeding with the specified seed mixture utilizing our rangeland drill, certified noxious weed-free native grass hay mulching at 2.0 tons/acre, crimping, and tackifying with GU Tackifier and XL Cross Linker.

Items not generally included in our revegetation services for landfills and also applies to this project, include: topsoil, topsoil handling and grading, rock picking (available if requested at additional cost), watering, maintenance, weed spraying (available on a time and materials basis) warning signs, barriers, site protection, or *stand establishment warranty*. Native, dryland species often require several years (approximately 3) to fully establish. Contact us for more information if desired.

As is true of most revegetation in Wyoming, Rocky Mountain Reclamation highly recommend **NATIVE** grass hay mulch in place of the often-used straw mulch. Grass hay mulch is more expensive per acre but is one of the best methods available to help minimize erosion at a minimum incremental cost. Hay mulch is far superior as a surface mulch over straw in the wind belts of the West. The price difference is a small incremental cost and, in our opinion, is an excellent value.

Rocky Mountain Reclamation utilizes a special type of hay mulch for mulching to minimize erosion potential and competition from undesirable plant species. This material is specially selected and is better than other hay mulches for erosion control and ability to remain on-site during heavy winds. In addition, our mulch is certified noxious weed free. This high-quality mulch is more expensive than typical hay mulch but is worth the small additional cost.

WARRANTY: Like all of our projects, Rocky Mountain Reclamation warrants workmanship and materials. Workmanship will equal or exceed industry standards and materials will be as specified and will be provided with material certifications. Rocky Mountain Reclamation guarantees the replacement of any defective materials or workmanship. However, we cannot warranty stand establishment as Mother Nature, soils, human impact, wildlife, insects, weather, and many other variables out of our control can negatively influence revegetation results.

**COMPOST** – Rocky Mountain Reclamation has applied compost on a number of landfill project around Wyoming, the most recent completed were in Wheatland and Casper. For this project, we are pricing at the 25.0 ton/acre specified application rate. We will be providing a high-quality compost per the specification; no local material will be utilized as none is known from the Rawlins area that will meet the specifications.

With these poor soils, compost is a good recommendation for this project. Compost to be applied with equipment specifically designed for even application of compost as opposed to loaders and motor graders with less capability to evenly apply and spread the compost. Incorporation includes special finish discs to turn and mix the compost to appropriate controlled depths as opposed to rippers, motor graders, and similar equipment that does not have the same capability to turn and evenly mix the compost with the existing soils as our scarifiers and discs.

Like almost all the projects we do, payment for revegetation work for this project is based on actual surface area completed and is not calculated on a flat plane basis. Prices and materials delivered are based on quantities per the plan sheets. Our prices assume the slope gradients have been taken into consideration when determining pay quantities. Our drill acre meter is very accurate and will measure the exact surface area drill seeded.

Prices good for 60 days from date of bid as requested in the bidding documents.

COVID-19 may affect all work in Wyoming and the USA and as such, we assume in the above pricing that it does not significantly affect the work on this project. We have protections in place and policies and procedures to create "Mobile Islands" for our crews to provide assurance to our Clients that our people will not increase risks of exposure when we arrive on-site. We have strong protocols for individual and Rocky Mountain Reclamation team protection and to date the virus is not affecting our ability to get materials and provide services to our Clients. Seed suppliers are slightly slower at providing seed orders due to reduced staff at their facilities, but have not significantly affected our scheduling to date.

### INTRODUCTION

**Scheduling:** Rocky Mountain Reclamation plans to complete the revegetation part of this project in approximately 5-7 full working days with one crew. Weather is almost always a factor; wind, rain, and other delays almost always keep us from working without some down time.

A number of different reclamation steps will be required to adequately revegetate and stabilize the areas designated. The procedures we suggest at this point in time are outlined below.

# Recommended Revegetation Techniques:

Basically, the probable procedures, based on past experience, are as described below. These recommendations are based on over 42 years of success in the area of this project.

Compost: Composted manure and organic material will be applied utilizing special equipment
designed for evenly spreading this type of material. Loaders and motor graders will NOT be used
as they are incapable of applying the compost evenly. The compost Rocky Mountain Reclamation
provides is high-quality compost, free of weed seeds, and is material that meets the specifications
for organic matter and Carbon to Nitrogen ratios. The compost will be incorporated with specially

designed finish discs to assure thorough mixing of the compost in the soil profile.

- 2. **Seedbed Preparation:** Prepare the seedbed for seeding. Includes scarifying and/or discing. Special equipment designed and built by Rocky Mountain Reclamation is used to assure a satisfactory seedbed that allows for maximum surface roughness and micro-topographical features to promote species diversity, yet allow for maximum seed to soil contact, snow capture, and moisture holding and infiltration.
- 3. Rangeland Drill Seeding: Rangeland drill seed all disturbed areas accessible with 4-wheel drive equipment. Seed Mix design and seed provided by our company. This process includes both drill seeding and "broadcast" seeding in the same operation to maximize seed germination potential. Rocky Mountain Reclamation utilizes an advanced method of broadcast seeding diverse shrub and small seed species to provide maximum return on your investment.
- 4. **Mulching** –**Hay**: Apply native grass hay mulch for erosion protection. - 5. **Crimping**: Hay mulch to be crimped into the soil as soon as possible after mulch application. A specially designed heavy weight, floating gang Rocky Mountain Reclamation crimper will be utilized for this operation.
- 6. **Tackifying:** Tackifying is available for this project, as necessary. The tackifier, if utilized, will provide significant assistance in minimizing erosion and damage to the mulch, seed, and seedbed during the interval between seeding operations and vegetation establishment.
- 7. **Steep Slope Soil Stabilization and Erosion Control:** Noxious weed-free native grass hay mulch will be provided for slope stabilization. This organic material will be incorporated into the soil by discing, crimping, or other equipment to satisfactorily provide a stable slope for seedbed preparation and drill seeding.

Following is a more detailed description of each revegetation technique we would potentially incorporate into this project:

<u>Compost:</u> Composted manure and organic material will be applied utilizing special equipment designed for evenly spreading this type of material. Loaders and motor graders will NOT be used as they are incapable of applying the compost evenly.

<u>Seedbed Preparation:</u> Scarifying and/or discing will be used as the primary techniques for seedbed preparation. Our specially designed scarifiers and RMR reclamation discs will be utilized exclusively for this project.

Rocky Mountain Reclamation utilizes special equipment, custom designed and built specifically for reclamation and revegetation of mines and similar disturbances in the western United States. Scarifying equipment was designed and manufactured by Rocky Mountain Reclamation. Rocky Mountain Reclamation discs are designed to provide variable soil conditioning on the go, something no other disc on the market is capable of doing. We can address variable site conditions appropriately in an efficient and accurate manner for our clientele.

Seeding: Drill seeding will be accomplished on the contour where possible. To the extent possible, seed will be placed to the depths indicated in the specifications, depending on the type of seed and soil textures. Application rates will be per specifications or our design based on edaphic and climatic conditions specific to the project. Broadcast seeding is not anticipated but if necessary, will be done at double the drill seeding rate.

Mulching: We highly recommend utilizing native grass hay mulch instead of straw mulch as the surface applied mulch. NATIVE Grass hay mulch applied at 2.0 tons per acre is a far superior mulch when compared to straw mulch on windy sites or areas with heavy precipitation events. NATIVE Grass hay is definitely worth the small incremental cost because of its significantly improved holding capacity and erosion control during wind and precipitation events as well as providing improved protection of young seedlings during vegetation establishment.

Rocky Mountain Reclamation mulching equipment is specially modified to provide maximum erosion protection by protecting fiber length of the hay mulch. Our mulchers are also redesigned for minimal repair requirements in tough working conditions. Special abilities to work on steep slopes provides our company with many advantages for accurate placement of mulch on slopes in windy conditions.

<u>Crimping:</u> We utilize specially designed floating gang crimpers available only to Rocky Mountain Reclamation. These crimpers are designed to adjust to the soil conditions. Crimping will immediately follow mulching operations to the extent possible.

**Tackifying:** The tackifier for the slopes will provide significant assistance in minimizing erosion and damage to the mulch and seedbed during the interval between seeding operations and vegetation establishment.

Tackifying is a procedure to further assure mulch and soil materials remain on-site. Tackifying significantly reduces soil erosional forces from wind and minimizes mulch and soil blowing off-site. We recommend tackifier for all areas with a high erosion potential, where aesthetic value is critical, and where blowing mulch and soil may cause problems with downwind neighbors. Because of the significant wind impact on seedling germination and plant establishment, utilizing tackifier is very important to the success of this project.

Utilizing the rates in the specifications will provide good stabilization. Based on private and government studies on projects in the West, Rocky Mountain Reclamation has determined the appropriate application rate for sites similar to this project and our recommended rates match to the rates in the specifications.
