A RESOLUTION OF THE GOVERNING BODY OF THE CITY OF RAWLINS, AUTHORIZING THE ACCEPTANCE OF THE AMERICAN RESCUE PLAN ACT (ARPA) OF 2021 FUNDS.

**WHEREAS**, City of Rawlins is eligible for funding from the American Rescue Plan Act of 2021; and

WHEREAS, the city is required to formally accept the ARPA funds; and

**WHEREAS**, this resolution establishes the budget for the project receiving the funds; and

**WHEREAS**, the City of Rawlins has received the first tranche in the amount of Seven Hundred Thirty-Seven Thousand, Nine Hundred Eighty Dollars and Five cents (\$737,980.05); and

**WHEREAS**, the project selected, Sage Creek Springs and Steel Line Emergency Repairs, meets the requirement of eligible uses, to make necessary investments in water, sewer, or broadband infrastructure (item #4, Interim Final Report, Eligible Use, page 26802, under "D"), and

**WHEREAS**, the city commits to remain in compliance with applicable budgeting, accounting, contracting, reporting, and other compliance for ARPA funds; and

**WHEREAS**, the Finance Director is required to separately track the ARPA funds and cannot be accounted for together with other grants; and

**WHEREAS**, the Finance Director is hereby directed to maintain sufficient specific detailed accounting records to satisfy the requirements of the grantor agency and the grant agreements; and

**WHEREAS**, the Finance Director is hereby directed to report the financial status of the project to the governing board on a monthly basis; and

**WHEREAS**, copies of this grant project resolution shall be furnished to the Finance Officer, the City Clerk, and the City Council; and

**WHEREAS**, the timeframe as a recipient of the ARPA funds begins on March 3, 2021, and ends on December 31, 2024, as long as the award funds for the obligations incurred by December 31, 2024, are expended by December 31, 2026.

NOW, THEREFORE, BE IT RESOLVED BY THE Governing Body of the City of Rawlins, Carbon County, Wyoming, accepts the American Rescue Plan Act of 2021 monies, and adopts the conditions and requirements as set forth in the Interim Final Rules (Department of the Treasury, 31 DFR Part 35, RIN 1505-AC77, Coronavirus State and

Local Fiscal Recovery Funds), and Compliance and Reporting Guidance for State and Local Fiscal Recovery Funds, June 24, 2021.
